On Demand Management Presentation	Marc Stilson, Colorado Authority of Utah
Discussion Conversation: Power point presentation with a breakdown of the following key components: ● COLORADO RIVER ECONOMIC POWERHOUSE - The Colorado River is a vital economic engine for the Western United States. The Upper and Lower basins span 250,000 square miles and support 40 million people. The river supplies water for seven states: Wyoming, Colorado, New Mexico, Utah, Arizona, Nevada and California. ● COLORADO RIVER AUTHORITY OF UTAH - In 2021, the Utah State Legislature established the Colorado River Authority of Utah (CRAU), a state agency focused on protecting Utah's interests in the Colorado River system. The agency was created to address the state's water needs amidst growing concerns about drought, population growth, and the need to renegotiate the Colorado River's operating guidelines. The CRAU is tasked with protecting, preserving, conserving, and developing Utah's Colorado River system interests. ● MEMBERSHIP - the Colorado River Authority of Utah has established five (5) advisory councils a Central, Northern, Southern, Southwest & Agriculture. These councils are designed to provide diverse perspectives and expertise on Colorado River issues ● POST 2026 NEGOTIATIONS - All seven (7) states agree that there needs to be a plan implemented to reduce water consumption. Both basins agree that the current operations are insufficient to protect water elevations in both Lake Powell and Lake Mead. The Lower Basin states have agreed to take the first 1.5 MAF of reductions, but now the negotiations are to determine who will take the additional reductions. . The Lower Basin States want to split the remaining reductions 50/50, but the Upper Basin States wants to recognize our hydrologic shortage, and then maybe split on a proportionality basis, because the Lower Basin States uses two to three times as much water as we do. The agreement will be temporary and hopes it to last twenty (20) years. ● FEASABILITY - The Colorado River's feasibility refers to the ongoing assessment of whether a Demand Management program, involving temporary, voluntary, and compensated water use reductions in the Upper Colorado River Basin, is feasible and advisable for Colorado and the other Upper Basin states. ● DEMAND MANAGEMENT PILOT PROGRAM - Refers to strategies for conserving water, particularly in the Colorado River Basin. It involves voluntary and compensated reductions in water use, aiming to keep more water in the river, maintain critical reservoir levels, and ensure compliance with interstate water agreements. The state also has a pilot program to compensate farmers for temporarily fallowing land, effectively saving water in the river. Conclusion Closing: "Marc Stilson" The mission of the Authority is to protect, conserve, use and develop Utah's waters of the Colorado River system.
