TOUR: Adobe Reservoir

Adobe Reservoir is part of the larger network of canals and reservoirs (including Swasey Diversion Dam and Joes Valley Reservoir) managed by the EWCD for supplemental irrigation in Emery County.

Conservation measures at the reservoir level primarily involve:

- System Integration
- Storage Management

The EWCD, which manages the water resources in the area, including the Cottonwood Creek-Huntington Canal and related reservoirs, employs several key conservation and efficiency measures:

- Real-Time Monitoring and Control System (RTMCS)
- Infrastructure Improvements
- Water Allocations
- Supporting End-User Efficiency:

The main conservation strategy in this area is a high level of technological monitoring and control over the agricultural water delivery network, moving away from unmonitored, less efficient methods.
